

services under the direction of probation officers. Deputy probation officers may be reimbursed by the county in which they serve upon voucher approved by the court to which they are assigned for necessary expenses incurred by them in the course of their duties.

The administrative committee of the district courts, in consultation with the commissioner of probation, may apply for and accept federal grants or assistance for the purpose of defraying the costs of additional clerical assistance, equipment, books, materials and other expenses incident to the services which such deputy probation officers perform.

Chap. 402. AN ACT AUTHORIZING CERTAIN POLITICAL SUBDIVISIONS OF THE COMMONWEALTH TO CONTRIBUTE ONE HALF OF THE COST OF CERTAIN PREMIUMS OF HEALTH INSURANCE OF THE SURVIVING SPOUSE OF INSURED ACTIVE OR RETIRED EMPLOYEES.

Be it enacted, etc., as follows:

Chapter 32B of the General Laws is hereby amended by inserting after section 9C, inserted by chapter 303 of the acts of 1967, the following section: —

Section 9D. A county by vote of the county commissioners; a city having a Plan D or Plan E charter by majority vote of its city council, any other city by vote of its city council, approved by the mayor; a district, except as hereinafter provided, by vote of the registered voters of the district at a district meeting; a regional school district by vote of the regional district school committee; a veterans' services district by vote of the district board; a welfare district by vote of the district welfare committee; a district established under the provisions of section twenty-seven A of chapter one hundred and eleven by vote of the joint committee; may provide that it will pay one half of the amount of the premium to be paid by the surviving spouse of an insured employee or a retired employee for hospital, surgical, medical and other health insurance continued as provided in section nine B. A town may provide for such payment if a majority of the votes cast in answer to the following question which shall be printed on the official ballot to be used at an election in said town is in the affirmative: — "Shall the town pay one half of the premium costs payable by the surviving spouse of an employee or retired employee for group general or blanket hospital, surgical, medical and other health insurance?"

Payment of the entire premium by the surviving spouse as required by section nine B shall not apply in any governmental unit which accepts the provisions of this section.

Chap. 403. AN ACT ROLLING BACK THE EFFECTIVE DATE OF AN ACT PROVIDING THAT TIME SPENT BY CERTAIN POLICE OFFICERS AND FIRE FIGHTERS ON THEIR RESPECTIVE RESERVE LISTS SHALL BE CREDITED AS FULL TIME SERVICE FOR PURPOSES OF RETIREMENT.

Be it enacted, etc., as follows:

Section 2 of chapter 509 of the acts of 1966 is hereby amended by striking out, in line 4, the word "sixty-four" and inserting in place thereof the word: — sixty-three.
