To The Honorable, The City Council:

I am hereby requesting the appropriation of \$50,548.00 in the Grant Fund of the Department of Human Services Salaries and Wages Account (\$3,000.00) and the Ordinary Other Maintenance Account (\$47,548.00) from the Massachusetts Executive Office of Elder Affairs. These funds represent the total of the FY98 Formula Grant awarded to Cambridge, based on population of residents age 60 and over. Funds will be used to support general operations of the Council on Aging, including contracted transportation services for medical and grocery shopping; a part-time coordinator of substance abuse services for seniors; and Senior Aides who work part-time providing phone and reception coverage at the City's senior centers.
