SUBJECT: 1991 HOME RULE LEGISLATION

Please be advised pursuant to Order Number One dated September 24, 1990 as submitted by Councillor Duehay, I have, effective December 4, 1990, re-submitted to the House Clerk the following legislation:

1. AN ACT TO PERMIT THE CITY OF COUNCIL TO ENACT ORDINANCES REQUIRING PERSONS OR ENTITIES BUILDING OFFICE OR RENTAL DEVELOPMENTS IN CAMBRIDGE TO CONTRIBUTE MONEY OR LAND TO MITIGATE THE IMPACT OF SUCH DEVELOPMENTS ON THE SUPPLY AND COST OF AFFORDABLE HOUSING IN THE CITY.
2. AN ACT RELATIVE TO ASSAULT AND BATTERY UPON CERTAIN PUBLIC SERVANTS.
3. AN ACT RELATIVE TO ASSAULT AND BATTERY UPON CERTAIN PUBLIC SERVANTS.
4. AN ACT RELATIVE TO ASSAULT WEAPONS IN THE CITY OF CAMBRIDGE.
5. AN ACT AUTHORIZING THE ESTABLISHMENT IN THE CITY OF CAMBRIDGE OF A HOUSING TRUST FUND.
6. AN ACT AUTHORIZING THE ESTABLISHMENT IN THE CITY OF CAMBRIDGE OF HOUSING MITIGATION FEES.
7. AN ACT RELATIVE TO THE LICENSING OF ALCOHOLIC BEVERAGES IN CAMBRIDGE.
8. AN ACT AUTHORIZING THE CAMBRIDGE LICENSE COMMISSION TO PUSH BACK THE OPENING TIME FOR PACKAGE STORE SALES TO TEN O'CLOCK ANTEMERIDIAN.
