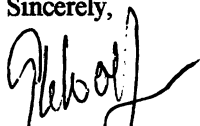
At the suggestion of City Councilor, Jonathan Meyers, I am writing to seek a spot on the agenda for the next meeting of the City Council to consider my request to place two benches outside of The 1369 Coffee House located at 757 Mass Av., Central Square.

The benches would be for the use of our customers as well as for the general public. We would not provide outside service or consider this to be restaurant seating. We propose using benches similar to those at City Hall and would probably leave them outside permanently. There would be no tables or umbrellas.

There is plenty of space for the benches. The sidewalk is approximately 20' wide in front of the store and the benches are about 20" deep by 4, 6" long. There are other establishments in Central Square with less sidewalk space and more seating.

We are new to Central Square and we want to provide a pleasant outdoor environment and to be of service to the community. The benches have the support of the neighborhood and I ask a favorable ruling on my request. Thank you for your consideration.
