Dear Council Members:

In connection with Calendar Item Number 1, the same being an application for an annuity in the amount of \$1,500.00 for Hazel Smolar under the provisions of General Laws, Chapter 32, Section 95A, I hereby submit the following opinion.

Dr. Smolar was employed from October 1927 to April 1, 1943 as a school dentist on a part time basis. His salary in 1943 was \$1,100.00 per year. He was pensioned in 1943 under Chapter 120 of the Special Acts of 1919 at \$550.00 per year. In 1965 his pension was increased through various statutes to \$1,100.00 per year.

As a result of the above investigation, it was determined that Dr. Smolar was employed on a part time basis. Chapter 32, Section 95A deals with employees who are employed on a full time basis. Therefore, it would appear that Hazel Smolar is not entitled to an annuity under Chapter 32, Section 95A.




To the Honorable, the City Council:
