We are very much opposed to the Cafe's request to upgrade their liquor license from a six day license to a seven day license. Our neighborhood is a quiet residential neighborhood, and we are inconvenienced and annoyed by the noise and parking congestion caused by the River Street Cafe.

We are firmly opposed to the liquor license being upgraded to seven days. We would like this issue to be put on the agenda for the city council meeting on Mon. Jan. 25, and if there is anything the city council can do to influence the license commission, we are asking for their help.
