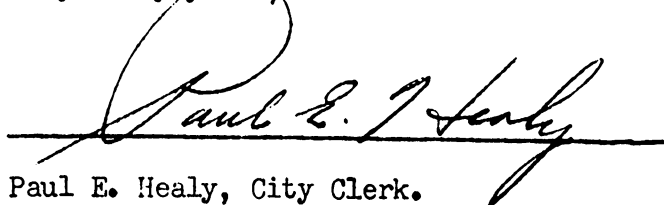
Enclosed herewith you will find the petition of Episcopal Divinity School
