- WHEREAS: Cambridge Health Alliance's department of emergency medicine cares for 80,000 patients annually, including 30,000 at The Cambridge Hospital, and is a precious resource for the City of Cambridge. Patients of all ages, backgrounds and incomes benefit from this service; and
- WHEREAS: Tom P. Workman, M.D., of Cambridge, has recently completed seventeen years of service as Chief of Emergency Medicine for Cambridge Health Alliance, the Site Chief for The Cambridge Hospital emergency department; and
- WHEREAS: During his tenure as Chief, Dr. Workman has guided the emergency department through five accreditation surveys, overseen major facilities upgrades, established express care services, and assumed responsibility for the Somerville and Whidden Hospital campuses; and
- WHEREAS: During his tenure as Chief, the number of patients seen annually has increased substantially, and Cambridge Health Alliance's emergency departments have the reputation of being compassionate, safe, and high quality places to receive care; and
- WHEREAS: Dr. Workman has developed excellent working relationships with community partners, including fire, rescue, ambulance, other area hospitals, and our public health department, and is highly regarded as a skilled physician, leader and collaborator; now therefore be it
- RESOLVED: That the Cambridge City Council, on behalf of all the residents of Cambridge, do hereby most profoundly and sincerely thank Tom P. Workman, M.D. for his dedicated service to the City of Cambridge and its citizens and wish him the best in the next phase of his career; and be it further
