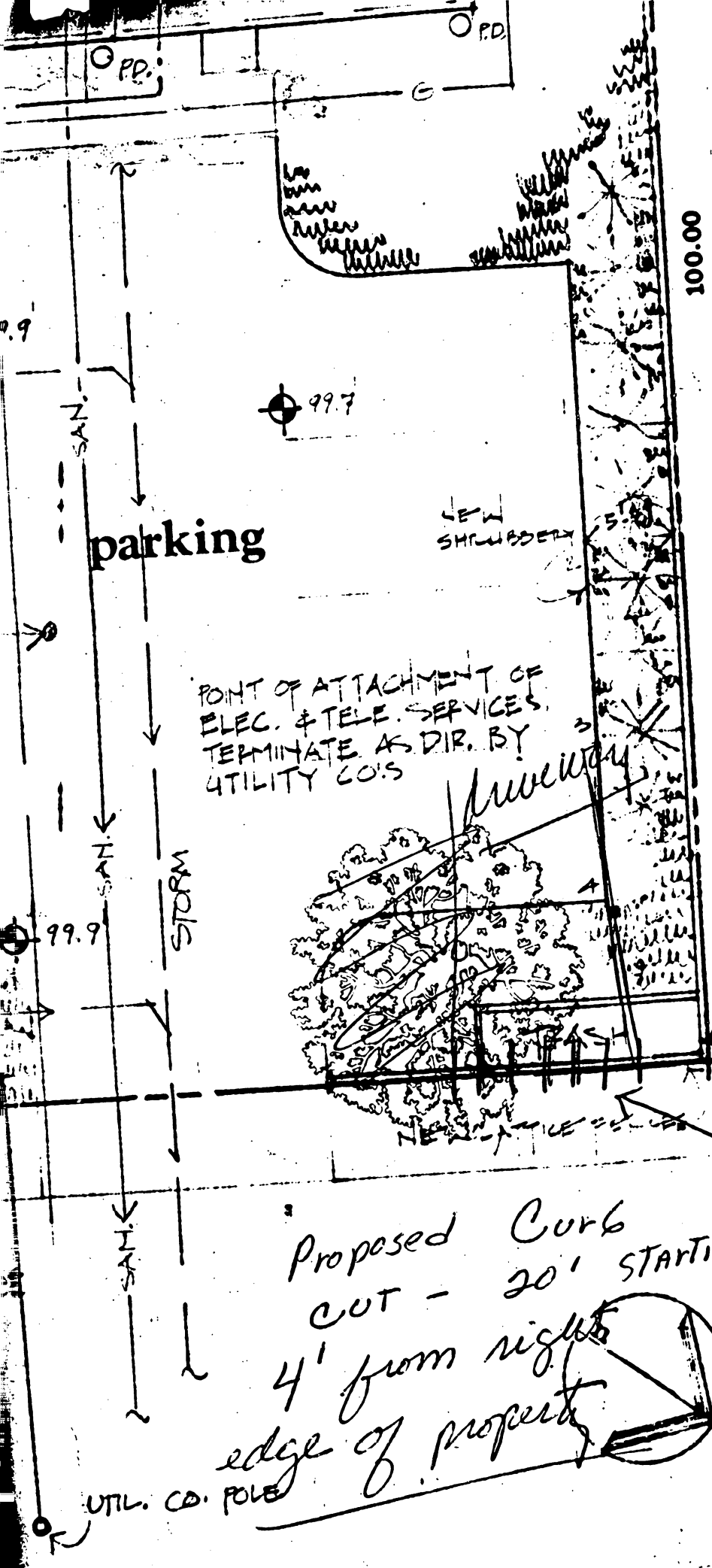

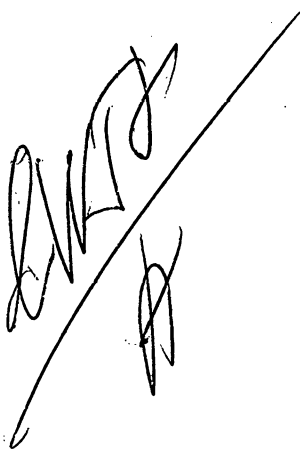
Location of proposed driveway 24 Prince Street
