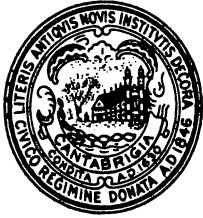


This transfer is necessitated for the following reasons:
