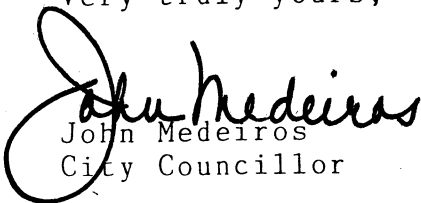
Dear Councillors:

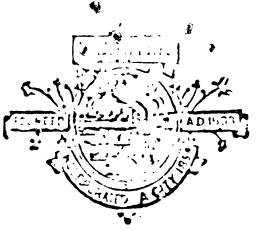

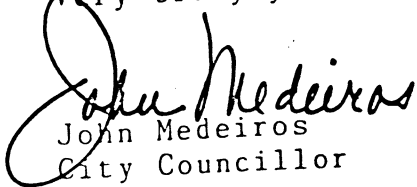

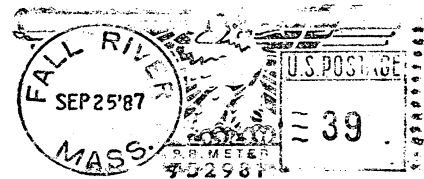
