To The Honorable, The City Council:

I am hereby requesting the appropriation of \$10,000.00 in the Grant Fund of the Department of Human Services Other Ordinary Maintenance Account from the Massachusetts Department of Housing and Community Development. The Homelessness Intercept Program was created when the State combined the Housing Search Program and the Housing Services Program. These funds will to be used to help prevent homelessness by providing counseling for tenants and landlords, mediation for disputes between tenants and landlords and housing search assistance for families facing eviction. The funds will be used to pay for first or last month's rent, security deposits, back utility payments and moving related expenses for Homelessness Intercept Program clients between now and June 30, 1998.
