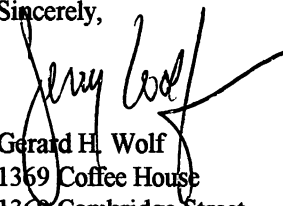
At the suggestion of City Councilor, Jonathan Meyers, I am writing to seek a spot on the agenda for the next meeting of the City Council to consider my request to place a bench outside of The 1369 Coffee House located at 1369 Cambridge Street, Inman Square.

Unaware that permission is required, we did put out a bench for about a week before we were reprimanded and ordered to cease and desist by the city Bench Busters. The bench was for use by anyone, not just patrons. During that brief time, we received several dozen positive comments and the bench appeared to be widely favored over the adjacent cement bus stop.

There is plenty of space for the bench. Our shop has 30' of frontage to the corner on Cambridge Street and 65' on Inman Street. The sidewalk is 13' wide in front of the store and the bench is only 20" deep by 4' 2" long. Enclosed please find a photo of proposed placement.

We try to take pride in our storefront. I have personally twice planted the city provided planter. The bench is an improvement and is supported by the neighborhood. I therefore seek a favorable ruling on my request. Thank you for your consideration.
