Metro Mobile CTS of New Bedford, Inc., managing general partner of New Bedford Cellular Telephone Company ("NBCTC") has filed with the Department of Public Utilities ("Department") for approval of the transfer of control of the certificate of public convenience and necessity ("certificate") held by NBCTC to Bell Atlantic Enterprises International, Inc. ("BAE"), a Delaware corporation. BAE is a wholly-owned subsidiary of Bell Atlantic Corporation ("BAC"). If this transaction is approved by the Department, BAC would obtain control and ownership of the facilities. NBCTC would continue to hold the license and certificate.

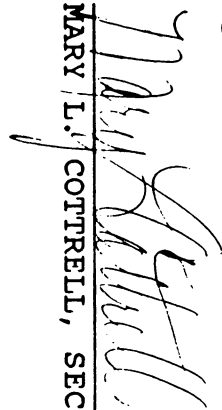
