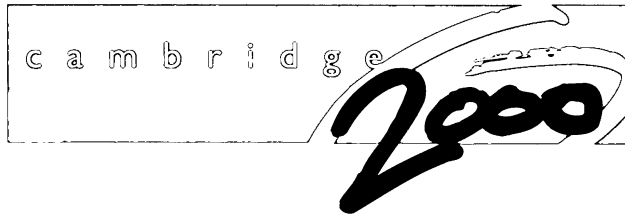

To the Honorable, the City Council:

I am hereby requesting the appropriation of a grant from the Massachusetts Department of Education, through Employment Resources, Inc., for \$17,722 to the Grant Fund Human Services Salaries and Wages account (\$14,040), Other Ordinary Maintenance account (\$3,502), and Travel and Training account (\$180) to provide funds to enable the Community Learning Center to provide Adult Secondary Education classes. These funds will cover a portion of the salaries of a full-time teacher, a full-time counselor, and a full-time technology coordinator, as well as program expenses and required conference attendance.
