On November 22, 1982 said charter right, communication numbered 17-21 in your agenda was tabled until the December 6, 1982 meeting.

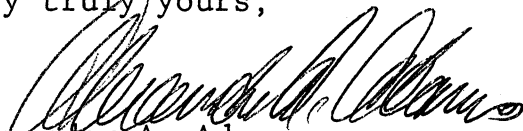
On November 22, 1982 a memorandum, accompanied by documents, was forwarded to your attention outlining the history of petition.
