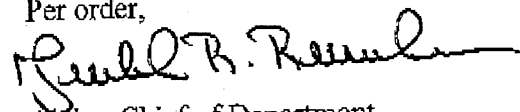
He was transferred to Engine Company 1 on October 29, 1963, where he remained until his retirement.
