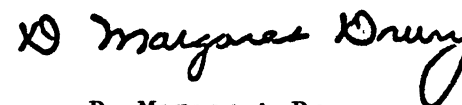

I am hereby requesting the appropriation of a grant from the U.S. Department of Justice, Bureau of Justice Assistance for \$222,544.00 to the Grant Fund Police Other Ordinary Maintenance Account to complete the implementation of the laptop computer program in marked vehicles. When this program is complete, all marked vehicles will have the ability to run listings, warrant checks, license history, and car-to-car dispatch messaging. The remainder of the allotment will be used for community partnerships to establish crime prevention programs involving cooperation between community residents and law enforcement personnel.
