I am hereby requesting an appropriation of \$61,500.00 in the Grant Fund of the Human Services Salary and Wages Account (\$60,235.00), Other Ordinary Maintenance Account (\$1,175.00) and Travel and Training Account (\$90.00). The Massachusetts Department of Education has awarded this grant to the Community Learning Center to provide basic skills and computer classes as well as counseling for homeless adults. Funds will be used to cover a portion of the salaries of two full time coordinators, two full time support staff and one part time teacher as well as operating expenses and required conference attendance.
