To the Honorable, the City Council:

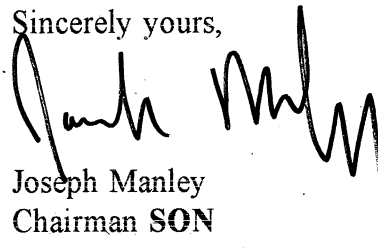
SON membership has surged by 13 members in the last week alone, for a total of 53 members. As before, roughly half are Cambridge residents. We attached an updated membership roll.

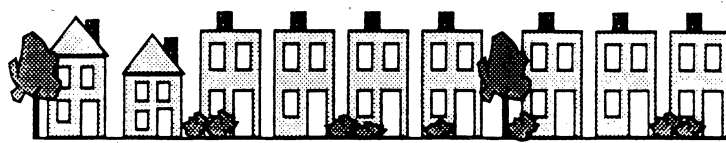

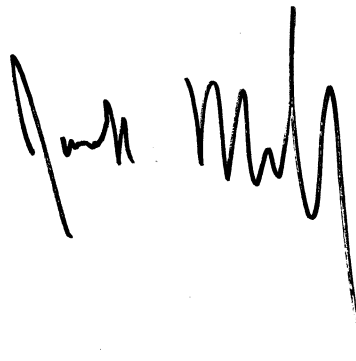
