We would appreciate your efforts in requesting the City Council to order a transfer of \$100,000 to our account in the Auditing Department. These monies have been appropriated by the 1973-74 City Budget to LEAA Match Funds under the Miscellaneous Category. This \$100,000 will be used to match our three Federal Grants in the following manner.:

The Core Youth Resources Bureau (73C-015-111) will receive \$73,467 on its 1973 Grant, and \$4,444 on its 1974 grant.

The North Cambridge Delinquency Prevention Program (73C-016-1131) will receive \$6,850 on its 1973 Grant.

The East Cambridge Job Resources Bank, (now combined with the Youth Resources Bureau), will receive \$15,239.

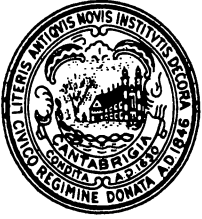


To the Honorable, the City Council:
