My name is Arthur H. Maringas. I own and live in a 3-family home at 89 Allston Street in Cambridge. The property is not under rent-control.

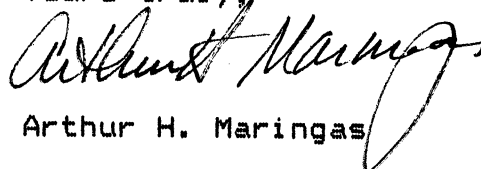
