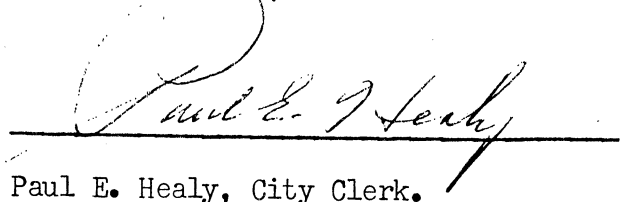
Dear Mr. Zussman:

Your kind cooperation in this matter will be greatly appreciated.

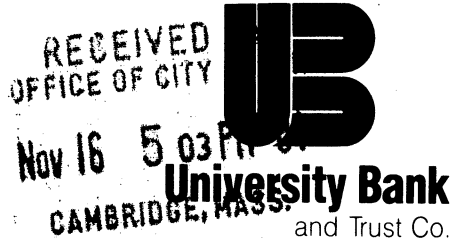

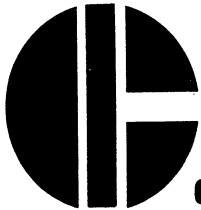
