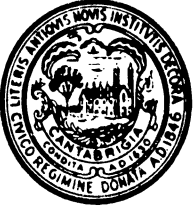

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$3,291.00 in the Grant Fund of the Department of Human Service Programs Salary and Wages Account (\$1,116.00), Other Ordinary Maintenance Account (\$1,915.00), and Travel and Training Account (\$260.00). The Adult Literacy Resource Institute has awarded the Community Learning Center a mini-grant to design a home-buying readiness virtual visit web page. Activities include: researching agencies offering assistance and non-traditional home-buying programs; learning web page development through CCTV classes; and creating web pages to be used as links on CLC and CCTV web sites. Funds will be used to cover the costs of a teacher, as well as operation and training expenses associated with the project.
