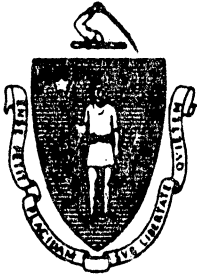

NOTICE OF PUBLIC HEARING

The Department of Public Utilities will hold a public hearing on May 22, 1984 to determine whether the Department should adopt proposed regulations designed to create sample test procedures for new residential and small commercial gas meters.

The proposed regulations would establish procedures for the sample testing of new residential and small commercial gas meters. New meters would be selected at random for testing by the Department. If a sufficient number of meters from a given lot or batch were rejected, then the entire lot or batch would be rejected.

Presentation of data, views or argument relating to the proposed regulations may be submitted by any interested persons at a public hearing to be held on May 22, 1984 at 10:00 a.m. in the forenoon at the Department offices, 100 Cambridge Street, Boston, Massachusetts.
