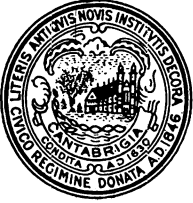

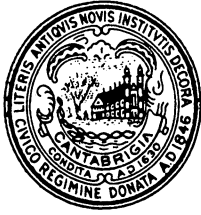
I respectfully request \$25,000.00 transfer from A-1,


