Attached is an order requesting the appropriation of a grant from the State Executive Office of Communities and Development for \$143,430.00 (comprised of funds from the State, DOE/EXXON and EXXON) to the Community Development Department Grant Fund Salaries and Wages account (\$879.00), Other Ordinary Maintenance account (\$142,026), and Travel and Training account (\$525.00). The funds will cover the operating costs of the Weatherization Assistance Program for the period of July 1, 1987 to September 30, 1987.
