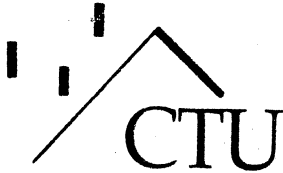

On behalf of Cambridge tenants who live in apartments under rent control, the Cambridge Tenants Union herewith submits the original sheets of a Petition to the Cambridge City Council.

The petitioners request that this City Council convene hearings immediately to address the problem of general rent adjustments and, out of those hearings, "develop a new and fair method for general rent adjustments".

As members of this City Council are surely aware, the Cambridge Rent Control Board has used the current flawed formula since 1985 and has, in all that time, failed to do any more than tinker with it. As a result, since 1985 rents under rent control have risen faster than inflation and many "controlled" rents are now higher than the market will bear. Recently, some landlords have admitted they are now charging less than the Rent Board's Legal Maximum Rent.

It has long been clear that the current policy for general rent adjustments, a policy which has produced such inane results, must change. Tenants are now asking the City Council for help in making necessary and constructive changes.
