ORDERED:

That the City Manager be and hereby is requested to instruct the Commissioner of Public Works to also comply with all provisions of the union contract in order to avoid confusion, unrest among our employees and all unnecessary litigation as well as the costs incurred by same, and be it further

ORDERED:

That the employees of the Public Works Department, in accordance with their labor contract, receive full compensation for Friday, December 24th and the Christmas Holiday, December 25th and be allowed to work until Friday Noon as required by their contract entered into with the City of Cambridge, and be it further

ORDERED:

That this same procedure apply for the New Year Holiday and Martin Luther King Day, due to the fact that each of these holidays fall on a Saturday and the union contract provides that these employees be paid for the holiday.
