WHEREAS:

In July 1978, the City Council adopted a resolution endorsing the East Cambridge/Lechmere Triangle Development project as outlined in the Urban Development Action Grant application submitted to the U.S. Department of Housing and Urban Development;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CAMBRIDGE:

1. That the parcels listed in Exhibit A be acquired for development as public open space, as part of the East Cambridge/Lechmere Triangle Development project;
2. That an Application be submitted to the Commonwealth of Massachusetts Executive Office of Environmental Affairs for acquisitions funding under Chapter 933, Acts of 1977, the "Urban Self-Help Program";
3. That the City Manager, or in his stead the Assistant City Manager for Community Development is hereby authorized and directed to execute and file such application with the Executive Office of Environmental Affairs, to make any amendments to the application or the program proposed in such application as may be required, to provide such additional information, furnish such documents and execute such contracts as may be required, and to act as the authorized correspondent and representative of the applicant in connection with said application;
4. That the Commonwealth of Massachusetts and the Secretary of Environmental Affairs be and hereby are assured of full compliance with all assurances and understandings as may be required.

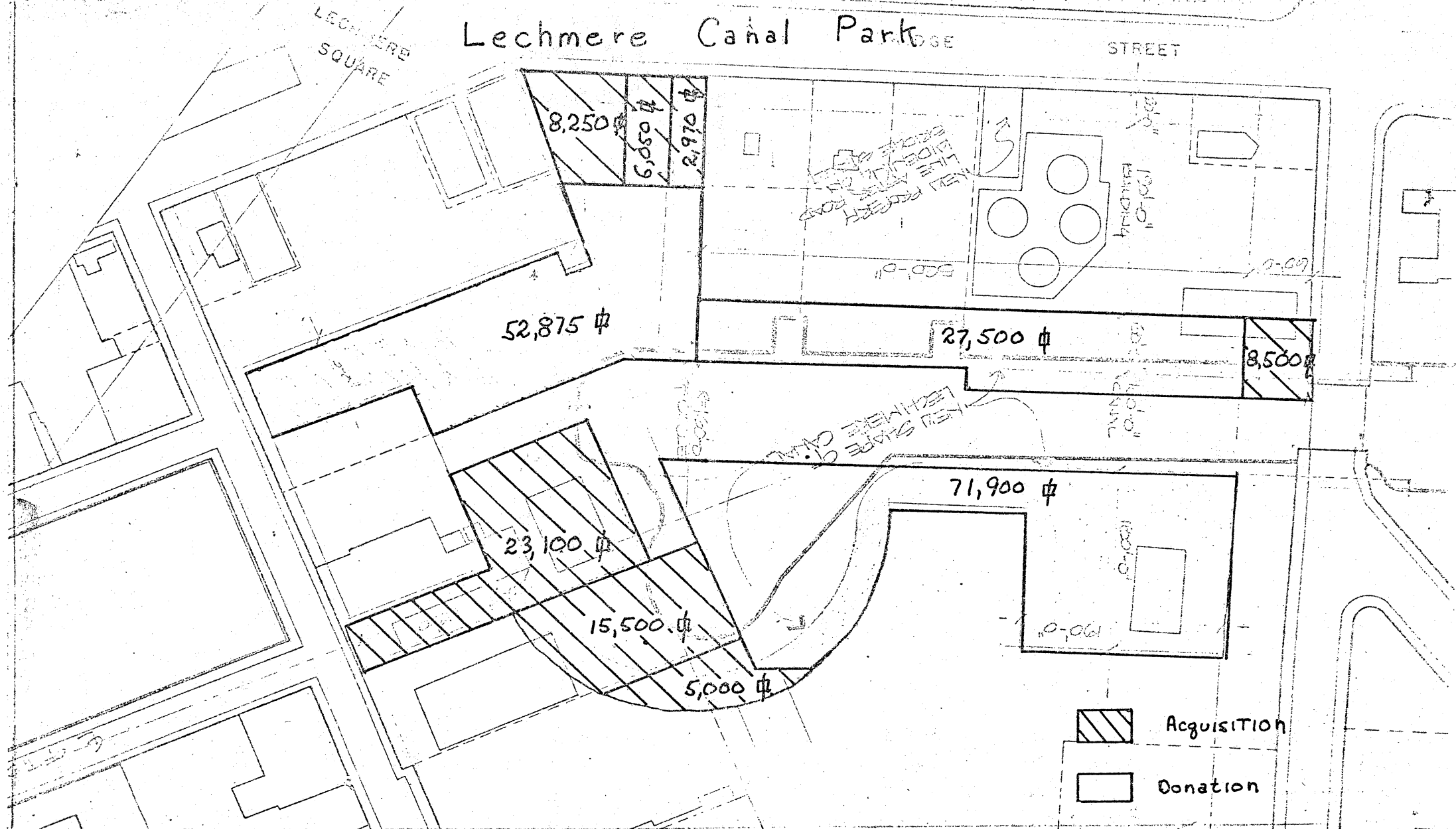

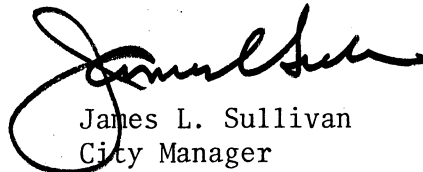
