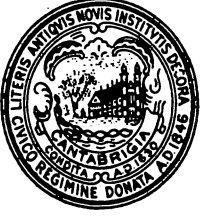
Please be advised that this office will require a supplemental appropriation of \$35,000.00 to the legal counsel account.
