To The Honorable, The City Council:

Attached is an order requesting the transfer of \$15,000.00 in the General Fund from the Rent Control Department Salary & Wages Account to the Rent Control Department Other Ordinary Maintenance Account to provide funds for a computer consultant to assist in the final stages of conversion of the Rent Control Computer system to ADMINS, the programming language used by most other city departments.
