I am hereby requesting the appropriation of \$164,117.00 in the Grant Fund of the Department of Human Services Salary & Wages Account (\$23,416) and the Other Ordinary Maintenance Account (\$140,701) from the Massachusetts Department of Education's Bureau of Nutrition. The Department of Human Services operates the Summer Food Services Program for Children annually. These funds will be used to cover costs associated with providing meals during the summer to Cambridge youth at 36 sites throughout the City including summer camp programs and drop-in meal sites.
