Provided that, before erecting the above named sign, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of **Two Thousand Dollars (\$2,000.00)** conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said sign.

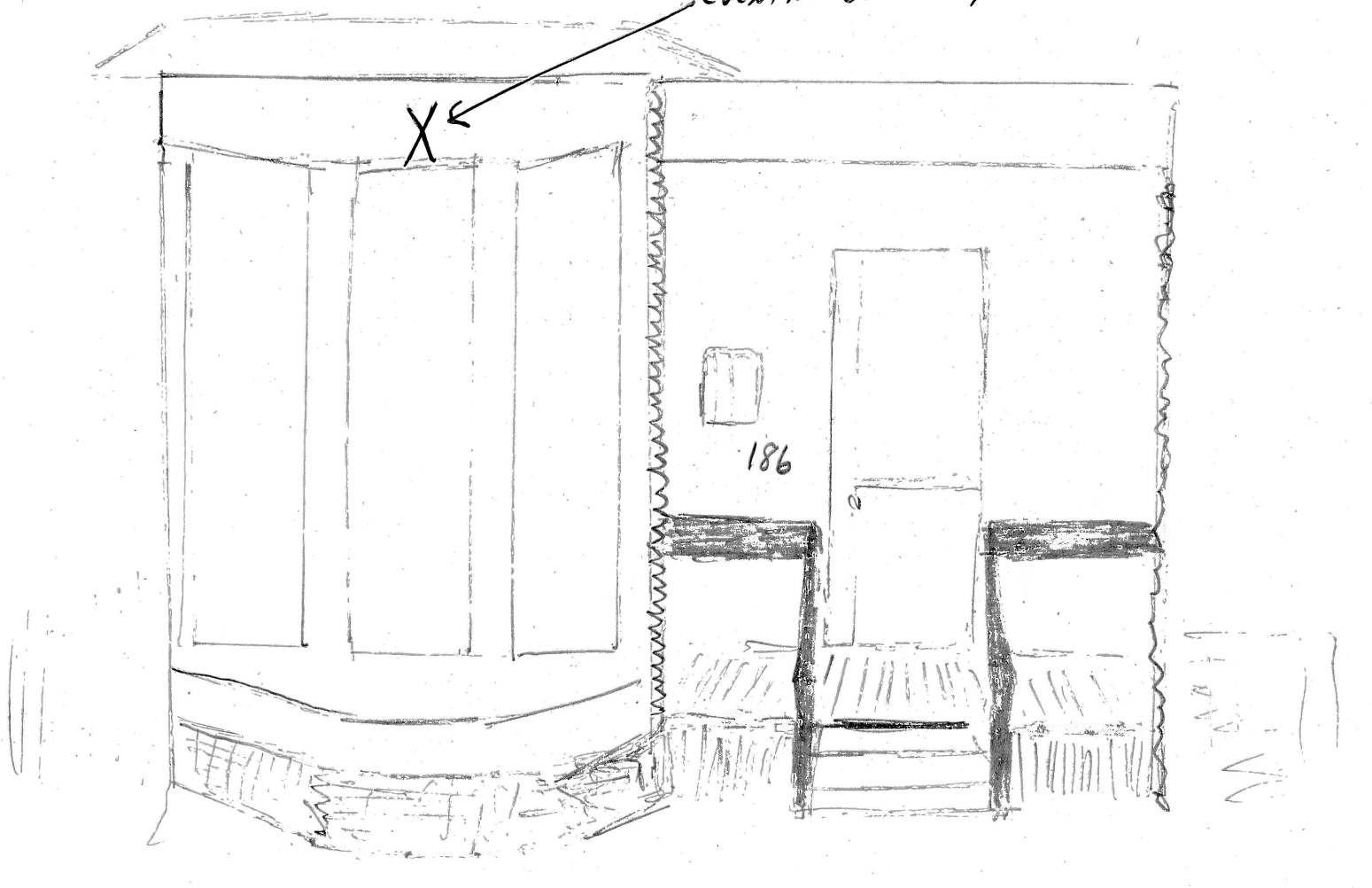
