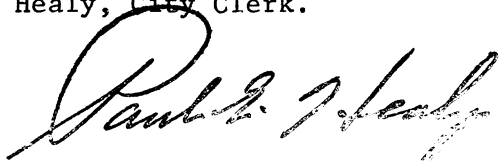

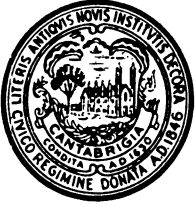

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$64,413.00 from the Massachusetts Department of Public Welfare to the Department of Human Service Programs grant fund. This appropriation should be budgeted in Salaries and Wages (\$51,510.00) and Other Ordinary Maintenance (\$12,903.00).
