To The Honorable, The City Council:

I am hereby requesting the transfer of \$3,154.90 in the Grant Fund of the Department of Human Services from the Salary and Wages Account to the Other Ordinary Maintenance Account. The Planning and Development Division's Supportive Housing Program award from the Department of Housing and Urban Development funds grants to homelessness services providers. The grant allows for 5% of subcontracts to be used for grant management. When originally calculated, however, 5% of the entire grant award was calculated. This transfer represents a downward adjustment to reflect the correct percentage.
