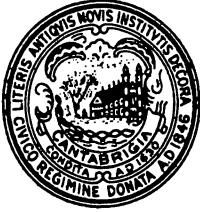


To the Honorable, the City Council:

Last week the City Council voted to override the Appropriation Cap, Levy Cap and School Appropriation Cap by certain amounts. Subsequently, the forms from which these Cap figures were computed were reviewed by the Department of Revenue of the Commonwealth. Due to a difference in interpretation of these forms the figures that were voted last week must be amended to read as follows:

Appropriation Cap	\$3,242,139.00	6-1-2
Levy Cap	8,885,624.91	6-1-2
School Appropriation Cap	7,418,345.42	17-0-2

Approving these figures will not affect the tax rate in any manner. However, approval of these amended figures is required for the State to approve the rate.
