IN CITY COUNCIL

April 11, 1983

ORDERED:

That the Commissioner of Public Works be authorized to construct driveways over sidewalks in front of estates upon the streets as hereinafter named, the expense thereof to be charged to the appropriation for Public Works Department, Paving (Edgestones and Sidewalks). The entire cost of material and labor furnished to be repaid to the City by the owners of the abutting estates.

and be it further

ORDERED:

That this permit is granted subject to the following conditions, the failure to comply with will be cause for the revocation of this permit:

1. That there be a five-foot setback for any parking installed at the rear of the lot.
2. That the setback be planted with trees and shrubs in such a way as to screen it from the abutting houses.
3. That the expense of removing any utility poles, trees and any other material to construct the driveway shall be borne by the petitioner.

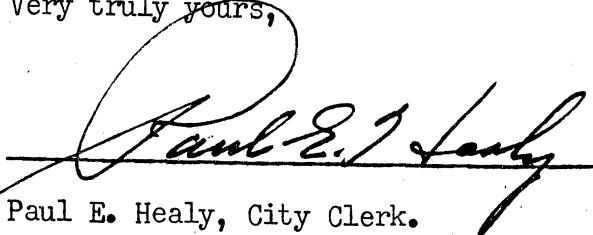
