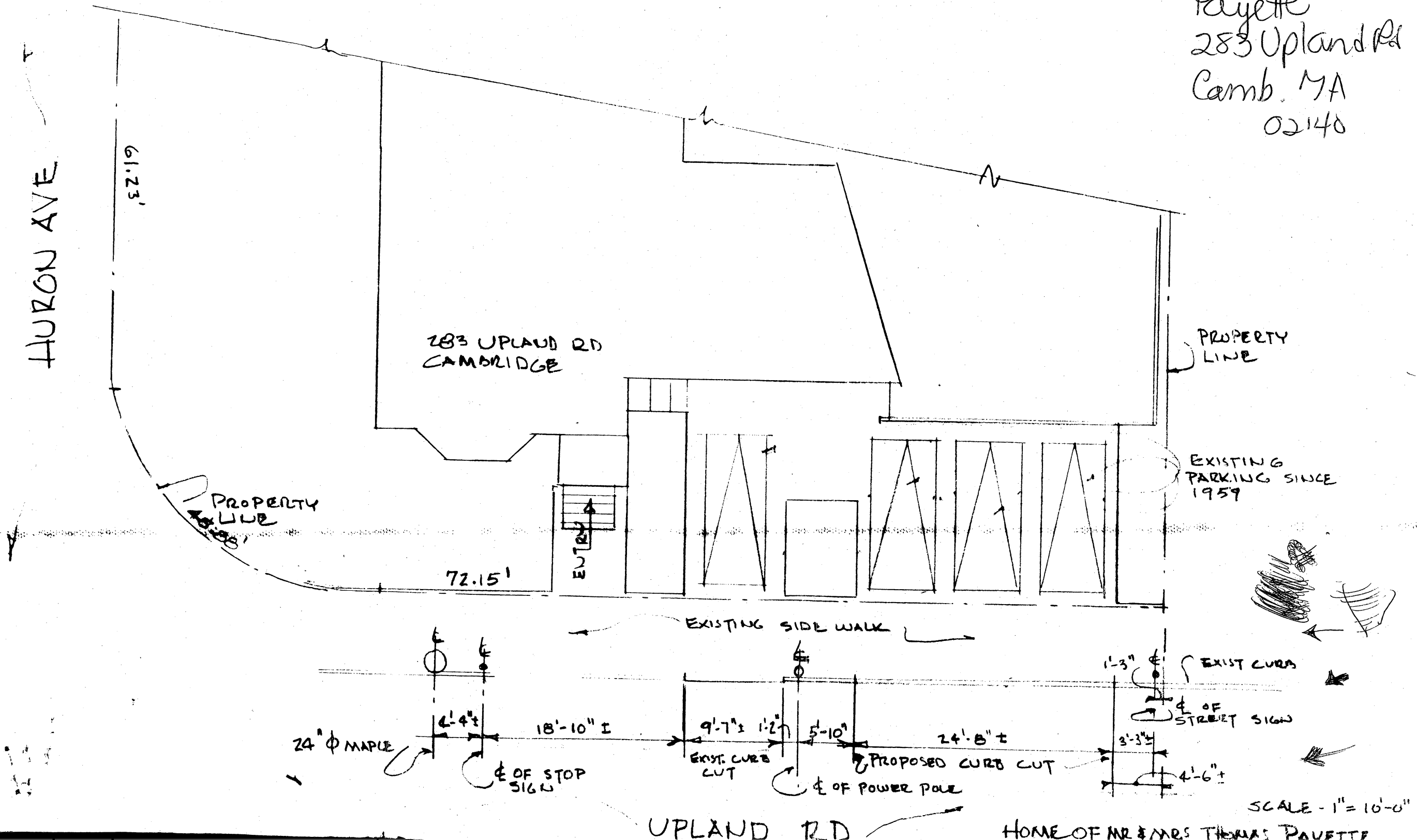
MEMORANDUM

The above property is located in a Residence B Zone and there is an existing curb cut.

The proposed curb cut is the second curb cut and the width of this curb cut is 24'8" - greater than 20 feet (6.433 a&c). The parking shown on the attached sketch shows front yard parking which is prohibited by zoning ordinance section 6.441(c).
