At its regular October 6, 1981 meeting the Planning Board reviewed the above referenced proposal:

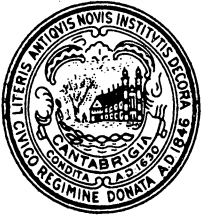
The Board finds no compelling planning issues involved in the suggested lease arrangement. The Board therefore, has no objection to any such action which will preserve and maintain this city resource for the future.
