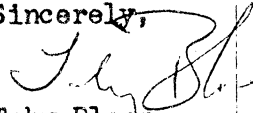
Dear Mayor Vellucci:

I am writing as a representative of the North Cambridge Neighborhood Alert to request an opportunity for our organization to appear before the City Council to discuss our concerns with State plans to rebuild the Route 2 / Alewife Brook Parkway interchange. Residents of North Cambridge have met twice in the last month to review plans and each time have left more concerned with the potential impact of this development on our neighborhood. While we, like you, would have liked to see Secretary Salvucci appear to explain his proposal, it is our strongly held belief that his refusal makes public discussion of this matter all the more imperative.

A few of the negative impacts that we feel must be explored include: increased congestion at Fresh Pond, an ugly, disruptive, elevated highway adjacent to residential neighborhoods, a disincentive to use of rapid transit, a disruptive construction process, and much, much more.

In addition we fear that the process, as presented by representatives of EOTC, has been designed to minimize public participation. We feel therefore, that our City Council must act in our interests. Residents of North Cambridge can be ready to present our opinions and concerns at the earliest possible date.
