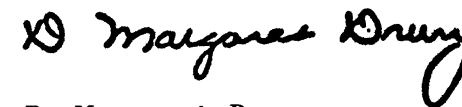

To The Honorable, The City Council:

I am hereby requesting a transfer of \$12,812.00 in the Grant Fund of the Department of Human Service Programs Center for Families from the Other Ordinary Maintenance Account to the Salary and Wages Account \$12,122.00 and the Travel and Training Account \$690.00. The Center for Families has received approval from the Massachusetts Department of Education to amend the FY98 Center for Families Grant. The increase in Salary and Wages will be used to cover the costs of increasing the hours of two part-time staff from 19 hours to approximately 30 hours per week. The increase in Travel and Training will be used to cover the cost of attending mandatory training and conferences.
