To the Honorable, the City Council,


Attached is an appropriate order for adoption of the City Council accepting a grant in the amount of (\$37,770) for funding of the Recreation Support Program.

This program is a continuation of an original Recreation Support Program grant made available in 1971 and provides supplemental recreational services to children in all neighborhoods ages eight (8) to thirteen (13).

This years program which began July 1, 1973 has been organized with the cooperation of the C.E.O.C. Board of Directors, which participates on an Advisory Board to the Recreation Support Program. To date this program has been very successful and has increased services through the participation and cooperation of private agencies; Community Schools, Recreation Department and the Youth Resources Bureau.

The City of Cambridge has just received the actual check and your acceptance of the grant will facilitate payment of already incurred financial obligations.
