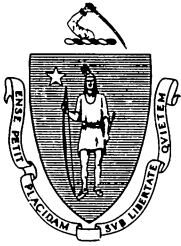

It is brought to your attention that the Mass. Dept. of Public Works must advertise this hearing in the major and local newspapers at least thirty (30) days prior to the date of hearing.

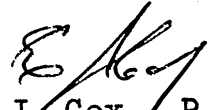
Either a daytime or night time meeting is acceptable.
