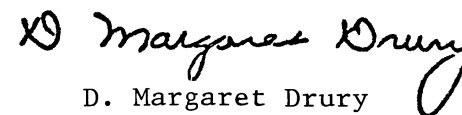

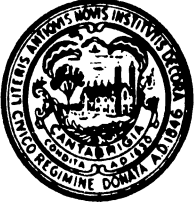

I am hereby requesting the appropriation of \$30,000 to the Public Investment Fund General Services Extraordinary Expenditures Account for the purchase of three copier machines to be placed at the following locations: the first one on the second floor of 57 Inman Street shared by the Peace Commission, Women's Commission, Human Rights and Workforce Department; the second will be on the first floor of 51 Inman Street and will be shared by Planning and Development, Cambridge Employment Program and the Cambridge Prevention Coalition which are three divisions of Human Services.
