Whereas, Rent control is a newly adopted program of the City of Cambridge and there is a special need for public explanation of the operation of this program.

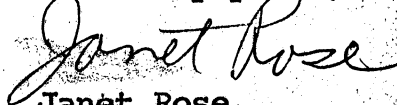
