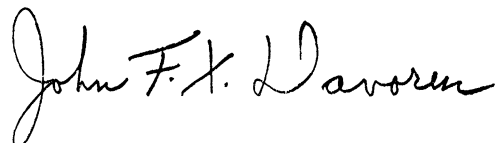

device, bequest, loan or otherwise, and generally to do any and all things in furtherance of the foregoing purposes; provided, however, that no part of the net earnings of the corporation shall inure to the benefit of any member, officer or director of the corporation, or any private individual (except as reasonable compensation for services actually rendered), and no member, officer, director, or any private individual shall be entitled to share in the distribution of any part of the assets or property of the corporation, whether on liquidation or dissolution or otherwise. Upon dissolution of the corporation or the winding up of its affairs, all of its assets and property remaining after payment of all of its liabilities shall be disposed of by being transferred to such other charitable, religious, scientific, literary, or, educational organization or organizations which are then exempt under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, and which is or are devoted to aims similar or substantially similar to those of this corporation in such manner as may be determined by the Board of Directors.

To engage in any lawful act or activities which corporations may be empowered to take in furtherance of its corporate purposes under Chapter 180 of the General Laws (~~Ter. Ed.~~) of the Commonwealth of Massachusetts as it may from time to time be amended.

To engage in all activities and to have and use all such powers as may be incidental or collateral to any of the foregoing purposes.

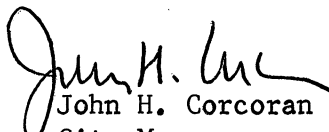
