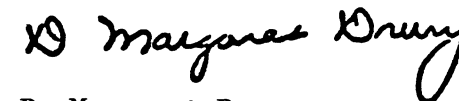

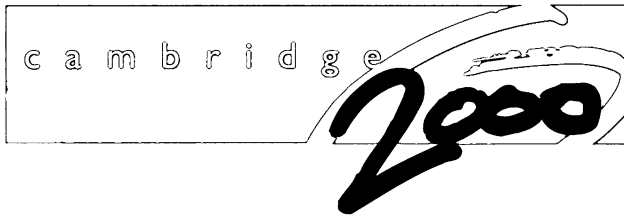

To the Honorable, the City Council:

I am hereby requesting an appropriation of \$110,944.00 in the Public Investment Fund of the Community Development Extraordinary Expenditures Account. The City received funds per the Cambridge Zoning Ordinance for a waiver of the parking space requirement in the Harvard Square Overlay District. For every space not provided, a fee equal to the cost that would have been incurred to build the space must be paid to the City for use in maintaining and enhancing the parking and open space system of Harvard Square. In the case of Special Permit #120, sixteen (16) spaces were waived and the developer was required to pay \$110,944 to the Harvard Square Improvement Fund, which administered by the Community Development Department.
