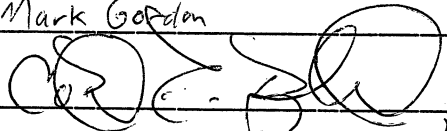

1. Whereas, although the Green Ribbon Commission resolved, in 1998, that Area 4 needs open space and, accordingly, used money from the Open Space Fund to buy the 238 properties for that purpose, the community residents were never asked what they wanted;
2. Whereas, although the Community Development Department held a series of meetings to discuss what sort of park should be developed, it never asked whether the community would prefer not to demolish the buildings at 238 Broadway;
3. Whereas, Cambridge already owns 238 Broadway and has already spent, approximately, 3 million dollars of tax-payer's money to acquire and rehabilitate the buildings, demolishing those two buildings may not be the best decision for that property as it affects the residents of Area 4 and Cambridge residents in general;
4. Whereas, since the passage of the Community Preservation Act, it would be possible to reimburse the Open Space Fund in order to keep the buildings standing;
5. Whereas, the development of a large, unsupervised space at 238 Broadway could leave the neighborhood more vulnerable to gang and drug activity, already a major problem in the neighborhood;
6. Whereas, if either one or both of the buildings were to be preserved or new buildings built for community use, there would still be a lot of open space available for the development of a newly designed park;
7. Whereas, the community has an opportunity to come together over this issue;

We ask that the Cambridge City Council delay the final decision regarding the buildings at 238 Broadway until the neighborhood organizations have had a chance to find a resolution that might better serve the needs of the whole community.
