IN CITY COUNCIL
June 21, 1976

ORDERED:

That the Commissioner of Public Works be and hereby is authorized to grant a permit to Nancy Ludgewart to set up a table in Harvard Square to distribute literature and information regarding the bicentennial on Saturday, June 26, 1976 between the hours of 10:30 A. M. and 3:00 P. M., subject to the following conditions:

1. That in the event the petitioner sets up a table in front on any business location, permission in writing be obtained from the owner or representative thereof.
2. That this permit, authorized by the City Council, be subject to the approval of the City Manager or his designated representative.
3. That the City Manager be and hereby is requested to survey the location of the table and ensure that no violation of the City Ordinance results from the issuance of this permit.
4. The violation of any of the foregoing conditions will be subject to the revocation of this permit.
